

GENERAL ELECTION PROCLAMATION

I, **Tanya Shelby, County Clerk** in and for the County of San Juan, hereby gives notice that a Statewide General Election will be held in San Juan County, New Mexico, in the various voting convenience centers on Tuesday, November 6, 2018. Voting convenience centers shall open at 7:00 A.M. and close at 7:00 P.M.

That said STATEWIDE GENERAL ELECTION shall be for the purpose of voting on the proposed Constitutional Amendments Nos. 1 and 2, and An Act "Authorizing the issuance and sale of senior citizen facility improvement, construction and equipment acquisition bonds; Issuance and sale of library acquisition bonds; Issuance and sale of bonds for the purchase of school buses, and the issuance and sale of higher education special schools and tribal schools capital improvement and acquisition bonds." Providing for a general property tax imposition and levy for the payment of principal of, interest on and expenses incurred in connection with the issuance of the bonds and the collection of the tax as permitted by law; Requiring approval of the registered voters at the 2018 General election of the state and for the purpose of electing candidates for the following offices of the various tickets respectively, to wit:


